Measure H Funded Contracts by SPA

Measure H funds the New Framework to End Homelessness, which consists of the Homeless Initiative's (HI) 5 new Pillars: Coordinate, Connect, Prevent, House, and Stabilize. Wherever reasonable, the funding is allocated regionally to each Service Planning Area (SPA). For Pillars where funding is allocated by SPA, in FY 2023-24, the allocation was determined based on each SPA's percentage of the 2022 Greater Los Angeles Homeless Count, as well as the geographic distribution of administrative homelessness data, where applicable.

Measure H funds for each Pillar are administered by one or more lead County agencies (such as LAHSA or the Department of Health Services), who in turn generally contract with community-based organizations and government entities to provide services/rental subsidies, as identified in the following chart. The chart does not include information about any subcontractors providing services under these contract agreements. The funding breakdown in the attached document is for FY 2023-24, and only reflects funding contracted to community-based organizations and government entities, not the total amount allocated for each strategy.
