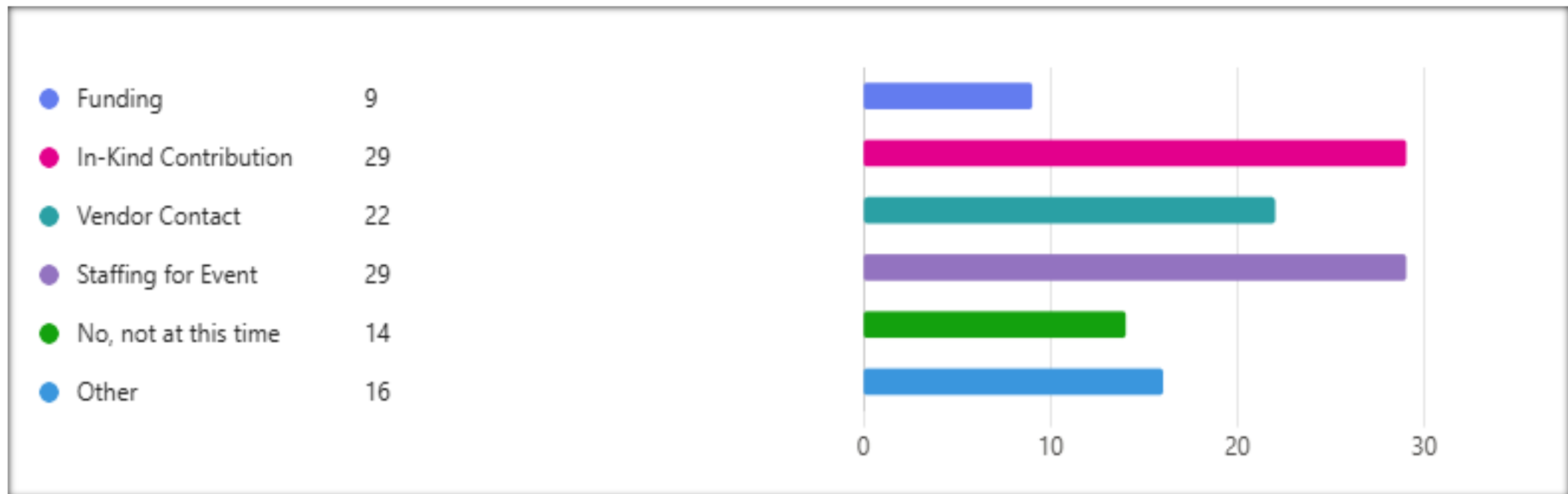
Survey Responses – Topics of Interest
