The Elevator Shop prepares an Elevator Status Report on Monday to Friday and shares it with the Chief Operations Officer. Service Requests are made for alignments that exceed the acceptable parameters.
- -On December 3, 2009, signs were installed on each side of the elevator cab doors on all floors of the Outpatient Department building. Signs were also placed inside of each elevator cab.
- -On March 8, 2010, caution signs for each elevator were placed in the General Hospital and the Intern Resident Dorm buildings, in the same location as in the Outpatient Department buildings.
