This non-litigated claim involves property damages arising from a sewer backup at the residence of Ryan Dawson located in the City of Agoura Hills. A County sewer crew investigated the complaint and found that wastewater from a sewer main line manhole entered the home due to a blockage in the sewer main line. The wastewater affected several rooms, including the master bedroom and bathroom, second bedroom and bathroom, and living room, and the associated floors and walls. The County crew rodded the mainline and relieved a stoppage created by tree roots. The sewer mainline is maintained by the

County as part of the Consolidated Sewer Maintenance District.

Due to the inherent risks and uncertainties involved in a trial, and the potential liability and potential exposure to an adverse verdict, the County proceeded with settlement negotiations and was eventually able to develop this recommended settlement.

Briefly provide a description of the incident/event:	This is a sewage backup that occurred at 28965 Valley Heights Drive in the City of Agoura Hills. The effluent overflowed into various rooms of the residence and caused damage to the interior and personal property of the claimant.
	On the day of the incident, Sewer Maintenance Division received a service request concerning a sewage floodout at the claimant's residence. A sewer maintenance crew responded to the location and confirmed the existence of a main sewer line blockage. The sewer maintenance crew proceeded to rod the main sewer line between Manhole Nos. 237 and 238 along Valley Heights Drive to break down the blockage.
	Prior to contacting the County and the initiation of the Rapid Response Program, the claimant obtained the services of an outside vendor, PuroClean, to perform immediate clean up on his property.

1. Briefly describe the root cause of the claim/lawsuit:

According to Sewer Maintenance Division, the sewer backup was primarily caused by a calcium buildup along with roots in the main sewer line. The main sewer line was last inspected on June 17, 2011, as part of the Preventive Maintenance Program. At the time, sewer flow conditions were observed to be normal.

 Briefly describe recommended corrective actions: (Include each corrective action, due date, responsible party, and any disciplinary actions if appropriate)

To prevent a reoccurrence of a floodout, the main sewer line was placed on a quarterly hydro periodic, and will remain on this schedule until it is no longer necessary as determined by sewer maintenance personnal. The main sewer line will also continue to be inspected semi-annually as part of the Preventive Maintenance Program.

NATURE OF CASE

David and Maria Hylla filed this lawsuit involving an automobile accident that occurred on May 3, 2010, at approximately 2:20 a.m. which caused the death of their daughter, Lisa Hylla, age 25. Ms. Hylla was driving a compact vehicle, northbound on the Interstate-405 Freeway approaching the Devonshire Street exit. Ms. Hylla rear-ended a pickup truck, causing it to spin and come to rest between the number five and six traffic lanes. Ms. Hylla's disabled vehicle came to rest in the number one lane. Ms. Hylla exited her vehicle and

was standing or walking north of her vehicle. A minute later, a Sheriff's Deputy in a marked Sheriff's patrol unit, also traveling northbound in the number one lane, was momentarily distracted by the debris in the roadway and the pickup truck. The Deputy saw Ms. Hylla's vehicle ahead, but he was unable to take evasive action before colliding into the vehicle. The collision caused Ms. Hylla's vehicle to collide into her and cause fatal injuries.

The Hylla's filed suit, alleging that the Deputy negligently operated the patrol unit. The County denies that the accident was caused by the Deputy's negligence and contends that Ms. Hylla was comparatively negligent.

Due to the risks and uncertainties of litigation, a full and final settlement of the case in the amount of \$750,000 is recommended.

As a result of the second collision, the plaintiff's daughter was killed.

This incident was thoroughly investigated by representatives of the Los Angeles County Sheriff's Department and the California Highway Patrol (CHP). Their investigations concluded that the deputy sheriff caused the second traffic collision by violating California Vehicle Code section 22349 (a), Maximum Speed Limit.

The Los Angeles County Sheriff's Department had relevant policies and procedures/protocols in effect at the time of this incident.

NATURE OF CASE

Plaintiff Bonni Sue Schopp ("Plaintiff") was seriously injured as a result of a vicious dog attack which occurred on August 23, 2010, at the Agoura shelter. The attack was the result of the alleged negligence of the Department of **Animal Care and Control** ("DACC") and Ms. Buxbaum ("Volunteer"), a volunteer at the shelter. The strict liability allegation was removed from the complaint following our successful demurrer, but the Plaintiff has plausible arguments for the remaining negligence and dangerous condition causes of action. The Plaintiff has had two surgeries on her arm to date.

Medical expenses are \$114,000 to date: there is also a \$10,000 loss of earnings to date. It is estimated that she will incur an additional \$50,000 or more for future surgeries related to the nerve damage in her arm, and to repair scarring. It is very probable she will continue to have pain, especially in her right forearm, for the balance of her life, with the only question being the level of that pain. Although surgery is included in the future medical expenses, the surgeon cannot guarantee he will be able to eliminate the neuromas and nerve entrapment which are causing that pain. She also has permanent sensory loss on the forearm, in addition to the pain. Those sequelae are from the severed nerves and scar tissue she developed due to the tearing bites. attempts at repair and healing. Also, because of the psychological problems caused by the traumatic attack, she has Post Traumatic Stress Disorder ("PTSD"), and she will require treatment for that, at least in the near term.

The incident occurred in one of the "Get Acquainted" areas while the plaintiff was interacting with a dog she was considering for adoption. The dog had been extremely friendly with staff and volunteers up to this point and had shown no signs of aggression, even during a medical examination and before and after neuter surgery. After playing with the dog for some time with no problems, the plaintiff picked up a large ball and raised it over her head to throw for the dog. This triggered an attack by the dog.

Briefly describe the <u>root cause(s)</u> of the claim/lawsuit:

The root cause of this incident is the unpredictability of animals. The County does not know the circumstances under which the animals lived prior to coming to the animal care centers. The animals may have had histories of abuse or neglect, or may harbor phobias regarding certain triggers that cannot be anticipated by the County.

 - 1. The Department has implemented the use of a Safety Information Acknowledgement form, which advises potential adopters interested in interacting with an animal about the unpredictability of animals; the unknown histories of the animals; physical movements to avoid; and the importance of monitoring child safety around animals. The form is in its pilot stage at one animal care center while being printed and should be fully implemented at all care centers

4. Corrective Action Plan Problem Statement

As part of its mission, the Department is charged with finding new homes for unwanted animals. However, many animals at the shelters arrive as strays and the Department has no history or background regarding their upbringing, training, temperament or medical history. Even owners who surrender their pets may not be completely truthful about the pets' behavior, medical status or other information helpful in evaluating the animals' suitability for adoption.

As part of fulfilling the mission of finding new homes for the animals, potential adopters wish to spend time with an animal they are considering for adoption to ensure that the animal is a good fit for their family, prior to the adoption. In response to this need, "get acquainted areas" have been constructed at all Department animal care centers which enable adopters to spend some time with the dog that they are interested in adopting in a quieter area away from the other dogs.

The Claims Board recommended to the Board of Supervisors the settlement of this matter in the amount of \$250,000.

Los Angeles Superior Court Case No. BC 432 895

This lawsuit concerns allegations of State and federal civil rights violations, negligence, and failure to furnish medical care to a minor under the supervision of the Probation Department.

The Claims Board recommended to the Board of Supervisors the settlement of this matter in the amount of \$161,000.
