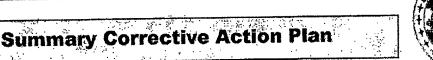

Our Sewer Maintenance Division (SMD) crew responded to a service request at the subject location and observed signs of a sewage overflow at the property.	
	The SMD crew broke down a heavy root stoppage by rodding the main sewer line between Manhole Nos. 415 and 416.

Based on our findings, this sewage overflow was caused by tree roots in the main sewer line between Manhole Nos. 415 and 416.

To prevent the recurrence of another sewer stoppage and sewage overflow at this location, the sewer mainline was placed on a 60-day rodder periodic and will remain on this schedule until it is no longer necessary as determined by maintenance personnel.
