Workshop Summary



Overview of workshop

A community workshop was held from 10:00AM-12:00PM at Athens Park Gym on Saturday, June 14, 2014 for community members to learn about the Earvin "Magic" Johnson Recreation Area Master Plan, and to share their opinions on the current assets of Magic Johnson Park and ideas for the future. Approximately 50 people attended the workshop, including two children and a teenager. In addition, two participants presented comments to facilitators that they had gathered from other residents.

The workshop began with a project overview and timeline for the park master plan, which will include improvements to existing facilities, new facilities, and would incorporate the former residential property of Ujima Village. The workshop facilitator then led participants through two activities to gather individual and group input into what they envisioned for the park master plan.

The first activity utilized Post-it Notes to allow participants to contribute their individual input on park assets ("best things about the park"), as well as ideas for improvement. Individual notes were grouped by theme and category, and the facilitators reported these common themes back to the group.

The second activity was a group activity that allowed participants to use ideas generated during the first activity, as well as incorporate new ideas, to contribute specific thoughts on improvements to the park. Each table was given a map and a worksheet to document their ideas, and had the opportunity to present back to the larger group what they had brainstormed.

The workshop closed with a reminder of future workshop dates, and an opportunity for participants to offer any other thoughts they had.

Activities

Activity 1 - Post-it Notes

In this large-group brainstorming activity, workshop participants were asked to write 1 to 3 thoughts on Post-its to say what they thought were the "best things about the park", as well as "ideas for improvements". The notes were quickly organized into themes which were reported back to the room for further comments.

The ideas presented in the Post-it Note activity by workshop participants were strongly connected to the themes they discussed in the group activity.

Top assets: Many participants noted the lakes and wildlife, along with walking paths, large spaces, trees, and parking.

Top suggestions for improvement: Improved cleanliness/appearance, a gym/recreation/activity complex, biking facilities, more exercise equipment, improvements to walking paths, and more/cleaner restrooms. There were also suggestions for several other types of amenities and facilities.

See **Appendix A** for participant comments from the Post-it Note activity, organized by theme.

Activity 2 - Group Discussions

Participants were given large maps of the park and worksheets to brainstorm top ideas for improvements. Using pens, markers, Post-it Notes, and dot stickers, workshop participants were encouraged to visually represent improved design and functionality of the park. Some groups wrote directly on the maps, while others used dot stickers to create a legend. There were seven groups, including one Spanish language table that also included youth.

Common themes: There were several themes and ideas that were repeated across groups, and which echoed comments from the Post-it Note activity. The ideas below were proposed by a majority of the groups.

- Basketball courts*
- Bike trail (one group suggested including a pump track; others mentioned the need to separate bicycling from walking)
- Children's playground equipment
- Community complex (groups proposed a community center, athletic complex, multipurpose center, and a center for the arts for Ujima Village)
- Consistent cleanliness (cleanup of messes left by ducks, people picking up after their dogs, more trashcans)
- Dog park (separate off-leash area for dogs)
- Exercise equipment
- Improved park entrance and more access points to park
- Improved restrooms (and restrooms throughout the park; two groups also mentioned a need for more water fountains)

- Lakes with clean water (some suggested stocking with fish)*
- Lighting throughout park (participants specifically mentioned a need in the northeast area)
- More parking
- More picnic areas
- More shade/shelters
- Pool (groups proposed both indoor and outdoor)
- Signage (including warning signs about lake depth, not feeding ducks, picking up after dogs)
- Skate park
- Soccer field improvements*
- Staffing at park
- Walking trail improvements

Workshop Summary



Overview of workshop

A community workshop was held at Athens Park Gymnasium on August 23, 2014 (Saturday) between 10:00am-12:00pm, for the community to review three (3) master plan conceptual designs for the update to the Earvin "Magic" Johnson Recreation Area. The three concepts were developed based on input from the #1 workshop participants on June 4, 2014, and historical project background material. Approximately 120 individuals attended the workshop, including several families with small children. Also, the workshop included representatives from Supervisor District 2 office, South Agency, Department of Parks and Recreation, and the RBF Consulting team.

The workshop began with a welcome and introduction to the project by County staff and consultant, and a summary overview of Workshop 1. The RBF team (landscape architect) described the three conceptual designs, the key design elements of each design and how these elements were developed for each concept. The workshop facilitator then led participants through two activities to gather individual input into the three designs.

During the first activity, participants placed dots on the boards stationed at the front of the room with each of the three concepts to show their preference for different attributes of each design. As they were placing the dots on the boards, participants had the opportunity to both fill out comment cards on their thoughts relating to the concepts, and could also utilize the flipcharts in the front of the room to give more feedback.

The second activity involved using survey polling equipment to further gauge participants' opinions on various aspects of the design. This activity also allowed the architect to further explain each concept, as well as answer questions on each of the designs. The polling software shared the results back with the workshop participants as the questions were answered.

The workshop closed with a reminder of future workshop dates, and an opportunity for participants to offer any other thoughts they had.



Activities

Activity 1 - Dot Exercise Activity

In this activity, participants were given 12 dots to place on any of the three concepts, as well as the pictures accompanying the designs. Three boards were set up in the front of the room, with a concept and accompanying graphics on each board. The landscape architects and consultants were available to answer questions on any of the design elements, and there were two flip charts available for open comments.


Some of the dots were placed in areas that are difficult to define (ie. a dot near "Splash Pad" might actually mean the Lake), but dots were counted and listed near the activity or design closest to the Dot, or with the group of Dots where the area for response was too small to contain all of the Dots.

Some design element categories were represented twice on a single concept, like the Equestrian Center and Outdoor Amphitheater. These Dot totals



are combined although they were on different locations on the board. The top 6-7 categories in each Concept are listed below:






Activity 2 - Survey Polling Activity

Participants were given polling devices to answer questions in relation to specific aspects of the designs, including the lake, the location of the parking, the amount of recreational amenities, the cultural centers/gymnasiums, and the walking trails. The final three questions related to how the participants rated the concepts overall. Between 78 and 95 people responded to each question.


Before closing each poll, the facilitator opened the room up for questions for the landscape architect. The results from the poll are meant not only to rate the different elements of the designs, but to provide an opportunity for the architect to clarify various aspects of the design and for participants to have the opportunity to ask questions.

Survey Polling analysis: The results from the polling questions are represented graphically in the order the questions were asked below. Analysis of each response, including comments made during the workshop, is included as well.




Question 1 – How would you rate the lake in Concept 1?

RBF team addressed questions relating to what the overall design of the lake was, as well as how Concept 1 was different than the other two Concepts in terms of activities on and around the lake.




Question 2 - How would you rate the lake in Concept 2?


Question 4 – How would you rate the location of the Parking in Concept 1?








Some participants expressed concern that there would be a road going so deep into the park towards the Nature Center, but some also expressed that they liked how spread out the parking was throughout the design.




Question 7 - How would you rate the amount of Recreational Amenities in Concept 1?


Question 8 – How would you rate the amount of Recreational Amenities in Concept 2?

RBF team shared the "cultural" aspect of Concept 2, and that although there was no gymnasium/rec center displayed on the design, any of the three designs could have a gymnasium.




Question 9 - How would you rate the amount of Recreational Amenities in Concept 3?

As in the previous question, the architect shared that a gym/rec center could be in Concept 3 even if it wasn't represented here visually.




Question 10 – How would you rate the Cultural Center/Gymnasium in Concept 1?

The architect pointed out the location of the gymnasium on Concept 1, and again emphasized that this design was more focused on recreation/ athletics.




Question 11 – How would you rate the Cultural Center/Gymnasium in Concept 2?

Participants asked whether or not the cultural center could be a gymnasium as well, and the architect said that anything was possible within the designs.




Question 10 – How would you rate the Cultural Center/Gymnasium in Concept 3?

Some participants expressed interest in the "Nature Center" as well as the Cultural Center.




Question 11 – How would you rate the Walking Trails in Concept 1?


Question 12 - How would you rate the Walking Trails in Concept 2?


Question 14 - How would you rate Concept 1 overall?


Workshop Summary



Overview of workshop

The final of three community workshops was held from 10:00AM-12:00PM at Athens Park Gym on Saturday, November 1, 2014 with the combined purpose of presenting the final conceptual plan for the Earvin "Magic" Johnson Park as well as serving as a scoping meeting for the Environmental Impact Report (EIR). The workshop was heavily attended with vocal participants numbering approximately 180 people. Thirteen participants utilized translation equipment. Many participants expressed negative sentiments about the equestrian center throughout the course of the Workshop, both in comments while signing in, through written comments, and during the environmental scoping discussion.

Upon arrival, participants were given information on the environmental scoping meeting, an agenda, and comment forms when they entered in order to speak or leave a written comment for the environmental scoping portion of the meeting. The Workshop was



opened by Joe Mendoza from the County, followed by a presentation by Juan Villalobos from RBF introducing the project and the community process that took place before the final conceptual design. A representative from the landscape architectural consultant AHBE presented an overview of the first three design concepts and then details on the final conceptual design. Community members were asked to hold their questions until the end, but several community members spoke up and expressed their dissatisfaction about the equestrian center being included in the design.

After the presentation, the consultants gathered the comment forms from community members and



categorized them by theme to present back to participants.

Environmental Scoping Meeting

The facilitators then transitioned the meeting to the Environmental Scoping meeting. Ruth Villalobos introduced the California Environmental Quality Act (CEQA) and Environmental Impact Review (EIR) process.

Much of the environmental scoping portion of the Workshop was focused on the process of the concept designs and the County's decision to include an equestrian center in the final plan and in all three conceptual plans when it was not mentioned as a given at the beginning of the process. Many participants who expressed negative sentiments about the equestrian center responded positively towards the rest of the plan.



Kathleen King from the County led the comment/discussion portion of the workshop, and read a series of comments from participants about their concerns related to the environmental process. Several participants expressed frustration about not being allowed to speak and instead wait until the presenter was finished reading comments. The presenter eventually allowed community members to speak. She emphasized on several occasions that the discussion was to be focused on the environmental process and not on the equestrian center, leading participants to phrase their questions and comments around environmental concerns related to horses. Of those who spoke, some expressed appreciation of the final design excluding the equestrian center, and others spoke about their concern for school safety during construction. Several commenters received standing ovations for noting the existence of the equestrian center, and several noted that the County should incorporate community comments into the next design.

Our road has not been touched in 4 years. Traffic is too heavy. I would like to see a play area for kids swimming area tennis court, skate boarding, police patrol in the park. I would like for Mark Ridgley to be at the next meeting if he wants our vote. Anything you do in this area let the community vote for it's our money not yours.

- Horse Center would create smells, horse poop along the trail. Danger of horses to people. You are putting horses above the people in this community. As a home owner, I will be paying higher taxes. Is there some way to reject the horse center? Are you and the outside backers of this program trying to harm home owners meaning gentrification? Not enough bathroom facilities. Bathroom design is important. Have you considered single stalls that have been used in other L.A. parks (that provide security). A park in Encino has single stalls. Put the water center in another part of the park NOT on the private land.

How many equestrian centers in the COC are located in an urban community? Are you aware that El Segundo Blvd. is a "proposed" route of the WesPac Jet Fuel Pipeline? Another social justice issue.
- Park has never been cleaned from oil tank farm. Before any changes are made the damage must be remediated. The county of LA won't talk about the contamination with the community because of law suits. This plan is a lot like the plan that caved problems in the first place. Don't build on contaminated site. This is being shoved down our throats.
- The park had (gasses) in the ground when they removed some of the drums in the ground. The water we drink sometimes smells like sulfur and gas. What can be done for the parking from the residents in our area?

Conflict of Interest

- Toxicity of the land chemical composition of proposed turf for soccer. Continued soil monitoring, keeping in mind those of us suffering with cancer. Hay causes allergic reactions for many. Our local horse owners allow or do not clean up wastes deposited on Belhaven. The Akbar family represents a conflict of interest. Indoor pool should be heated.
- Conflict of interest. Marisa Akbar and family have vested interests regarding the equestrian center. My autistic son went for therapy. But her stables were nasty. They have stables in the Richland Farms area of Compton and she cannot be assumed to represent without bias. Their stables smell. She does not live far enough to be impacted. We live across the street. Ridley Thomas chose someone who will personally benefit with prejudice. I don't want another

Need for Aquatic Center Over Equestrian Center

- This area consists of many senior citizens and equestrian center in not in the best use for surrounding community. An aquatic center would be best fit. Jessie Owens has a great aquatic program that is always filled to capacity. Being that the current duck poop is not cleaned up how is it that horse poop will be cleaned up. Bottom line horses are not a need of this community.
- I do not want an equestrian center in my community. An aquatic center would be a better fit. An indoor pool for swim lessons, swim team, water aerobics. This community will use a pool more than horses. Plenty will come from elsewhere but those who live here don't want an equestrian center.

As a member of the community, and current park user I have my opinion with the Majority of the community, that an equestrian center is not in our best interest and is something we do not want. Also why is the 'proposed' aquatic center located in a part of the park that is privately owned, prolonging its development, why not incorporated in a part of the park that is already county owned.

General Anti-Equestrian Sentiments

- We don't want horses in our area. What is going on with the ducks live there in the lake? We don't want higher taxes.
- My family and I have been in the community 20 years and we will love to see
 this project to improve and make our park beautiful and a better asset for the
 community. But don't agree with the equestrian center, horses need more land
 than what is going to be designated. And also we need to address the dog
 issues. Need improvements on street pavements.
- Please no equestrian center. Consider the safety of our children to this with the amount of water throughout the park. Children are attracted to water. We don't want drowning etc. Taxes is a question? Will they go up? No ducks in park (they poop all over the park)
- No equestrian
- I don't want horse trial in our community
- I am not in agreement with the horses
- Is the conceptual plan a done deal? The equestrian plan is a joke. The smell, the cleanliness effect. Do we have an opportunity to reject the equestrian plan? Will my taxes go up? Horses are not more important
- No horse, No goats, No Chicken All dog Park. Enda Aliewine would not like at all if she was living.
- Do not consider moving the equestrian center to 118th and Figueroa. We just had one removed from that area where people would ride their hoses at night and let them use the sidewalks and along the 100 freeway.

Support Equestrian Center

- I understand that some people don't want horses because they are allergies, but what about people who are allergic to dogs yet – they want a dog park.
- O I'd like to see the equestrian center be a part of the park. This would be great for the community and the youth in the area. I noticed in this meeting a majority present being seniors. May not have an immediate sensitivity or for equestrian this element really can serve the youth, future generating as well as those of us that are older. I'd like to see bike paths also incorporated.
- The Figueroa Horse Stables were privately owned with no centralized oversight or supervision. M.J. Park Horse facility will be organized and supervised. It could generate income by renting stalls. Horse manure can be collected in dumpsters, stored and even

- used and sold as fertilizer. Fly abatement can be controlled by a known fly controller called a natural fly predator (insect) that has proven to control fly populations. There are a lot of children that want to be exposed to horses.
- Horses are good animals, they are kind and loveable horses. I think horses should be in the park. I think horses should be in the park because they are kind animal that love people
- o It seems the community does not understand how an equestrian center works and how clean it is
- Our kids would like the opportunity to learn about horses at a 10 acre well-maintained facility. Many kids from LA have been learning about horse riding in other communities because there isn't a local facility. This is an activity that exposes our kids to experience that more affluent communities already have.
- Support for equestrian center mitigation for manure require manure management plan. Require stormwater management plan, flies, vector management plan. Runners and dogs on leashes allowed on horse trails to use walking. Horse trailer for loading and unloading that does not need to develop a county equine advisory committee. Develop a wetland for water purification. Develop a trail and dust mitigation plan.
- Equestrian Center would being property value up! Trails that lead to other area of the city. Hiring of staff that reflect the community. Which would provide residents a more sense of ownership. Especially when there a part of building construction.
- Public horse stables are cleaned daily manure hauls off or put in covered bins reduces flies and odor. The odor most people dislike is the smell from feed lots with cattle. Horses are vegetarians, feces not like dogs, cat or humans. No e-coli, manure is recycled hay useful for plants. Horses provide important recreational opportunities for youth and adults. El Fig stables were unsupervised on private land. This proposal equestrian center will be supervised.
- O An equestrian center would be an aspect in our community. Many people in our community have horses but no where to ride them. Having an equestrian center would bring variety and open new doors for kids in the community. - With the equestrian center, it brings horses, which brings flies and pesticides. This is not good for the environment around the houses. The air quality and the smell of the animals will affect the overall status of the residents in that area.
